Cause shall include, BUT SHALL NOT BE LIMITED TO and shall be subject to SPACE ODYSSEY USA, LLC's sole discretion, any inappropriate behavior, inappropriate dress, violation of the terms of this agreement, or any other behavior which, in SPACE ODYSSEY USA, LLC'S sole discretion, impacts on the high character and quality of the facility.

**NON-TRANSFERABLE/NON- REFUNDABLE:** This membership is non-transferable and this membership is non-refundable.

**RESTRICTION OR SUSPENSION:** SPACE ODYSSEY USA, LLC has the absolute right to restrict or suspend for a definite or indefinite period of time, the membership privileges of any member who SPACE ODYSSEY USA, LLC finds has violated any rule, regulation or policy established by SPACE ODYSSEY USA, LLC.
